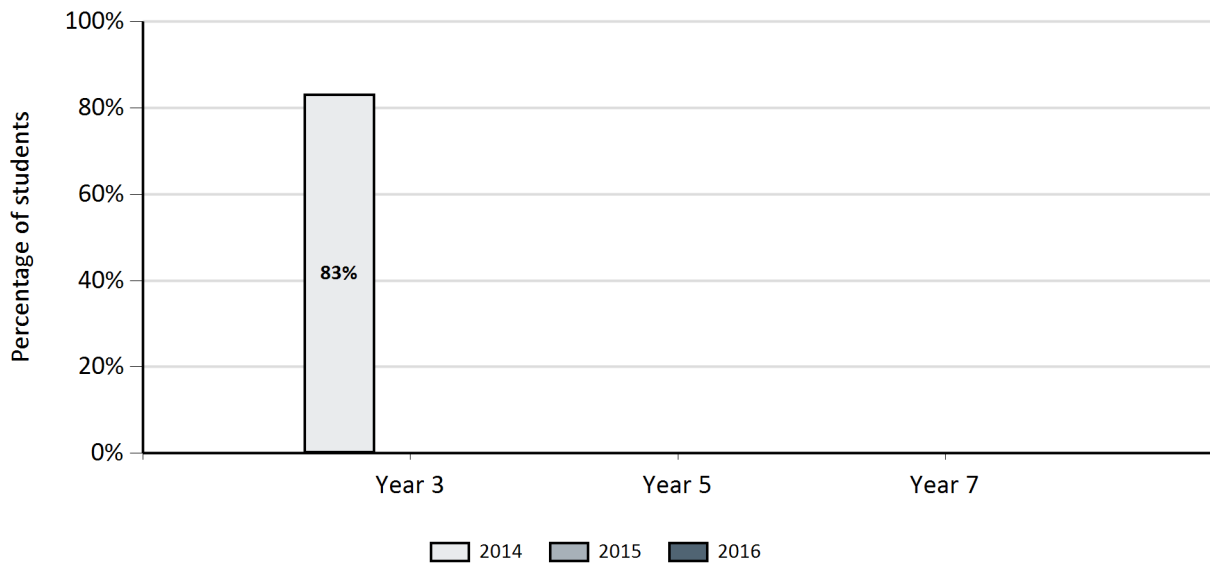

NAPLAN Proficiency

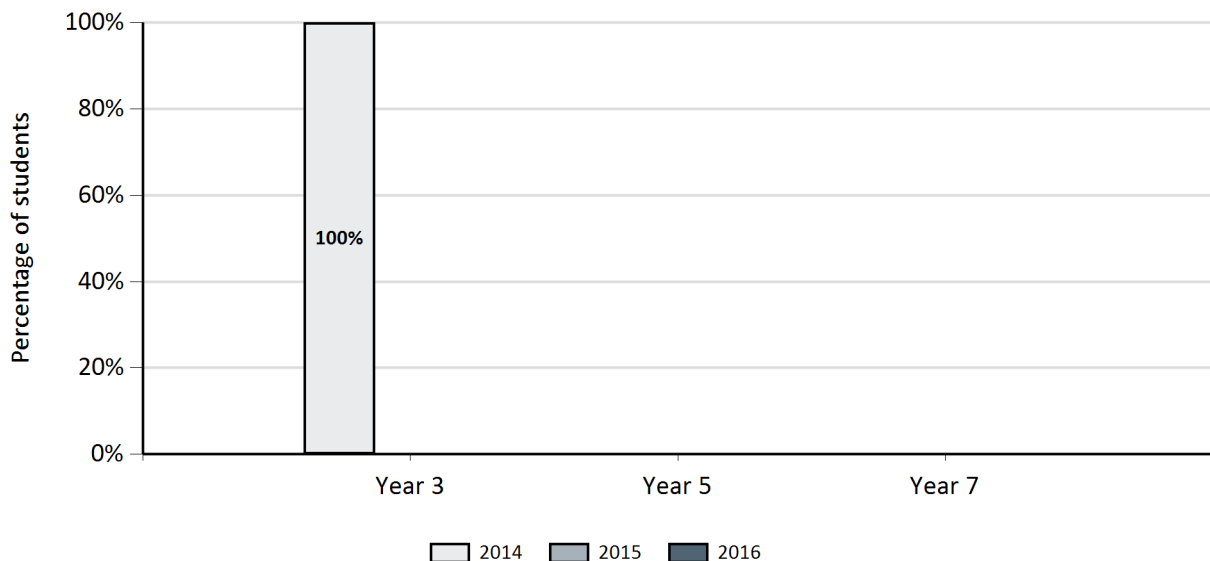
